To whom it may concern:

The Department of Natural Resources (DNR) recently approved the completion of the environmental work done at the Lee's Cleaners site. This letter describes how that approval affects your property; you are not required to take any action.

State law directs parties responsible for environmental contamination to take actions to restore the environment and minimize harmful effects. The law allows some contamination to remain in soil and groundwater if it does not pose a threat to public health, safety, welfare or to the environment.

On March 7, 2016, you received information from Ken Ebbott-Fehr Graham about the contamination at Lee's Cleaners. Contaminants remain in groundwater beneath your property. Over time, this contamination will clean up on its own. You are <u>not</u> responsible for cleaning up the contamination that has migrated beneath your property (Wis. Stat. § 292.13).

Please note that <u>your drinking water is not affected by the contamination</u>. Your drinking water is provided by the municipal water supply system, which is routinely tested to ensure the water meets federal and state drinking water standards.

If you construct or reconstruct a well on your property in the future, prior approval is required by Wis. Admin. § NR 812, to help ensure a safe well (use DNR form 3300-254: http://dnr.wi.gov/topic/wells/documents/3300254.pdf). Local ordinances may also apply.
