No worries Joe and thanks for the assistance. Our report for the period ending 12/31/2021 is as follows:

The Munger Landing Great Lakes Legacy Act project is currently in the remedial contracting phase with field implementation projected to begin in the Summer 2022. The project will remediate impacted sediments within the Munger Landing stretch of the St. Louis River. The US Army Corps of Engineers will oversee remedial construction activities on behalf of USEPA with participation by the WDNR, the Minnesota Pollution Control Agency (MPCA), and Paramount Global. The WDNR, the MPCA, and Paramount Global are collaborating as non-federal sponsors of the project. Paramount Global anticipates filing a BRRTS closure request upon completion of remedial construction.
