REMOVING THE FUELING HOSE FROM VESSEL FORT LLEGETH (LCS-3)
AND COLLING THE HOSE ON A SKID DOCKSIDE WITHEN DURING
APPROXIMATELY 2 GALLOS OF JR-5 ON TO OUR DOCK. THE
FUEL RAN INTO OUR LAUNCHWAY RAIL TROUBH WHERE < 1 RT
WENT THROUGH THE TROUGH DAAIN INTO THE MENDMINEE
RIVER, THE AREA WAS FRUY CONTAINED AND WE PAPUED
OIL SOAK SOOKS AND PADS IMMEDIATELY AS WELL AS
CLEAN OUT THE LANGHWAY TROUGH.
OUR CORECTIVE ACTIONS WERE TO SECURE THE FUEL HOSE
CAPS WITH CAM LOCKS ANYTIME THE FUEL HOSE IS MOVED AS
