Following an incident briefing at 1930HRS this is the information we have:

The fire at the refinery is out at this time, however firefighting personnel are not standing down. Additional personnel and equipment for firefighting and spill response is currently on its way. EPA is conducting air monitoring to assist with the decision to lift the evacuation. The goal is to lift the evacuation this evening. Firefighting water potentially left the site entering Newton Creek. Superior Refining has boom in place at approximately 7 places along Newton Creek. Superior Refining is going to begin surface water sampling of Newton Creek tonight. Superior Refining is going to begin recovery of fire fighting water tonight. A surface water sampling plan will be submitted tomorrow. Gov. Walker visited the Douglas County EOC at 19:00.

Update on Superior Refinery fire and explosion as of 1530HRS:

The asphalt fire at Tank 101 is still burning as of 1530HRS.

EPA is on scene and an air monitoring plan is being prepared.

EPA air monitoring contractors are en route.

An evacuation is ordered 6 miles wide and 10 miles downgradient (south) of the refinery.

A 7000 gallon anhydrous ammonia tank has ruptured due to fire.

There was 40,000 barrels of asphalt in the asphalt tank that is burning.

Superior Refining and DNR assessed Newton Creek from the mouth to approximately 1 mile up stream at ~1430HRS. No floating petroleum or sheen was noticed in Newton Creek.

Newton Creek is expected to be the primary route of any spills migrating from the facility. The underflow weirs on Stinson Avenue and at the 21st impoundment are closed to prevent spill migration.

Bay West (spill response contractor for Superior Refining) will be placing boom at the mouth of Newton Creek and upgradient as a precaution.

USCG is also monitoring Newton Creek and placing boom at the mouth of Newton Creek. The boom is being placed as a precaution. Spills to Newton Creek have not been observed at this time.

I spoke to Dave Beattie, Environmental Technologist, at Superior Refining Company at ~1034HRS.

The explosion and fire at the refinery caused several injuries from shrapnel and several people have been taken to the hospital. Exact numbers of injuries is unknown. The cause and exact location of the explosion is not known at this time. There is a large plume of smoke that is dissipating. There continues to be black smoke being released from the flair. Superior refining has notified John Tadelski, WDNR Air Engineer Eau Claire, of the air release. Superior Refining is setting up air monitoring equipment. One asphalt tank was ruptured from shrapnel and is leaking. The released asphalt is within containment and Superior Refining is responding to the release. At this time there are no reports of other spills associated with the explosion. This email will be updated when new information is received.
