Good morning John,

The groundwater investigation associated with the April 26, 2018, fire and explosion (BRRTS ID 02-16-581317) is still underway. The PFAS well installation field work is scheduled for November 2, 2023. Sampling will likely not occur until the spring of 2024 to allow for adequate development and recovery of the well.

A copy of the Platformer Technical Memorandum was submitted to you via email on March 1, 2023. I have attached an additional copy of the Technical Memorandum for your records. We also had a follow up meeting March 13, 2023, to discuss how to formally transfer the site to the facility wide.

At this time, SRC has not submitted a site summary and fee for the Platformer or the other sites that are still pending formal transfer requests.
