Dear Ms. Sellwood.

On behalf of Tyco Fire Products LP (Tyco), Arcadis submits this status report to summarize activities completed, data collected, corrective actions, and WDNR/Tyco correspondence for Q3 2024, as well as planned activities for the upcoming quarter (Q4 2024). As noted in previous quarterly status reports to WDNR, Tyco will continue to provide updates on a quarterly basis to reflect current and planned activities.

PROJECT STATUS

Below is a summary of the project status for the Tyco Fire Technology Center (FTC) and Stanton Street facilities and long-term drinking water supply for the period from July 1, 2024 to September 30, 2024 (Q3 2024) and planned activities from October 1, 2024 to December 31, 2024 (Q4 2024).

- July 1, 2024 to September 30, 2024 Point-of-Entry Treatment (POET) system sampling and operation, maintenance, and monitoring (OMM)
- July 1, 2024 to September 30, 2024 Private well sampling
- July 1, 2024 to September 30, 2024 Ditch A Treatment System OMM, weekly and quarterly sampling for the Wisconsin Pollution Discharge Elimination System (WPDES) permit, monthly downstream surface water sampling
- July 1, 2024 to September 30, 2024 Ditch B Treatment System OMM, weekly and quarterly sampling for the WPDES permit, monthly downstream surface water sampling
- July 1, 2024 to September 30, 2024 Deep private well installations (29 locations)
- July 1, 2024 to September 30, 2024 Short-Term Phase groundwater monitoring associated with the July 2021 Groundwater Extraction and Treatment System (GETS) Long-Term Monitoring (LTM) Plan

- July 1, 2024 to September 30, 2024 Weekly foam monitoring at Ditch A through Ditch E, foam was
 observed and collected from Ditch B until mid-July, no foam observed after mid-July for Ditch B and no
 foam observed during this period at Ditches A and C through E
- July 8, 2024 to July 15, 2024 Complete vertical aquifer profiling (VAP) sampling and monitoring well
 installations in accordance with the August 2023 Additional Site Investigation Work Plan for the FTC and
 the Response to April 17, 2024 Comments Response to Interim Long Term Monitoring Plan for
 Groundwater and Surface Water for the FTC dated June 3, 2024
- July 11, 2024 to September 30, 2024 Ongoing operation of pilot test at the GETS for new solids
 handling method utilizing Geotube (C) solids condensing system, in lieu of filter press use. This change
 has produced higher quality leachate water which in turn has allowed the sand filter to operate with fewer
 backwash cycles and improved system performance.
- July 24, 2024 Complete groundwater sampling at two wells in accordance with the August 2023
 Additional Site Investigation Work Plan for the FTC
- August 2, 2024 to September 30, 2024 Approval received from WDNR for GETS modification to utilize
 hydrogen peroxide as an oxidant in lieu of potassium permanganate as an oxidant. Preparations are
 ongoing to modify the dosing pumps to begin use of hydrogen peroxide and a switch of oxidant chemical
 is anticipated for early October.
- September 11, 2024 Q3 groundwater monitoring in accordance with the March 2024 Interim LTM Plan for Groundwater and Surface Water for the FTC
