Denice -

Thank you for sharing your updated schedule to the Groundwater Sampling Plan that was submitted to the DNR on May 8, 2024.

Because the May 2024 Groundwater Sampling Plan was submitted without a review fee for DNR response and knowing that you intend to collect data for the next year to assess suitability for closure, we wanted to take this opportunity to recommend that you sample from existing monitoring wells, rather than rely on results from the extraction wells for this assessment.

The monitoring wells should be selected based on the results from previous groundwater sampling for the VOCs (BRRTS 03-38-001345) and the groundwater flow and sampling results determined from the PFAS case (BRRTS 02-38-580694). The monitoring network selected for this assessment should include at least one in the historical source area (highest concentration) and others as needed to define the nature, degree and extent of VOCs in the groundwater.

If you would like DNR review and approval of the sampling plan for VOCs, please submit the plan to the DNR with a Wis. Admin. Code ch. NR 749 fee.
