Dear Messrs. Montney and Hartman:

The U.S. Environmental Protection Agency and the Wisconsin Department of Natural Resources (“Response Agencies”) have completed their review of the June 2023, Long-Term Monitoring Plan - Revision 1 (LTMP) for the Lower Fox River and Green Bay Superfund Site, Operable Units 2-5, submitted on June 19, 2023 by Foth Infrastructure & Environment, LLC, on behalf of Georgia-Pacific Corporation and Glatfelter Corporation. This revised LTMP was originally prepared by Anchor, Tetra Tech EC, Inc., Shaw Environmental & Infrastructure, Inc., and LimnoTech, Inc. and provided as Appendix I of the Lower Fox River Remedial Design 100% Design Report in 2011 which was approved by the Response Agencies.

The LTMP is a required program for monitoring the post-remediation recovery of Operable Units 2 through 5, and to assess progress toward achieving the remedial action objectives specified in the various Records of Decision. Consistent with the June 2011, Lower Fox River Operable Unit 1 – Long-term Monitoring Plan, Operable Unit 1 data will also be analyzed pursuant to applicable provisions of the Operable Units 2-5 LTMP to assure a complete river-wide assessment of remedial action objectives. The Response Agencies appreciate the extensive efforts of all parties to clarify the revised LTMP to aid in future decision-making, regarding achieving media and biota endpoints.


