You can proceed without “Specific Condition 17” in the NR 140 Infiltration/Injection Approval Letter, pursuant to the June 29, 2020 Remedial Action Design Report, that states, the existing groundwater monitoring wells will be abandoned prior to ISCO/soil removal implementation and replaced following implementation completion (for MNA groundwater monitoring). However, you must submit the monitoring wells abandonment forms to the DNR with an attached location map of the replacement monitoring wells according to the June 29, 2020 Remedial Action Design Report.
