Thank you for clearing up the concern with the figure Sheet 5, I have adjusted the figure accordingly. As to the "turquoise and pink lines on the north side of the property" they have no significance, it is just simply a result of the AutoCAD drawing being converted to a .pdf.

I will prepare a cross-section that shows the general redistribution of soils. Also, the excavation depths were intended to explain that the minimum depth of excavation was 2-3 feet and in general 3-4 feet though some locations were deeper as in the nearby utilities that were excavated down 7 to 8 feet. I will also address the items from your June 23<sup>rd</sup> email not covered in the recent submittal.

Hello Travis,

I received the revised NFA request, dated August 4, 2021; however, you did not provide responses to the specific items I requested in my June 23, 2021 email. Could you address these issues specifically, so that I can review the August 4<sup>th</sup> submittal along with this additional information. Also, provide a revised Sheet Number 5 so that the area identified in the Legend as "Minimum Area of Over-Excavation of 3-4 feet bgs or Greater" matches the hatched area on the map. The applicable area is not a solid orange color as indicated in the Legend. Also, identify the purpose of the turquoise and pink lines on the north side of the property.

As requested in my earlier email, a cross-section should be provided and would be very helpful for understanding the contamination and the soil movement that occurred at the site. For example, you

stated in the Findings and Conclusions that “the same area was excavated down a minimum 2-3 feet as a larger area of soil material onsite was deemed not suitable for construction....” Yet Sheet Number 5 indicates that a wide area around boring B-21 was over-excavated 3 to 4 feet or greater. Provide additional information about these excavation depths and the actual depths of the utilities in this area.
