Thanks for taking the time to speak with me last week. As we discussed, the SIWP is approved contingent on addressing the well-drilling procedures through the contamination on the Waupaca Foundry property. I located the well drilling procedures JCI used when drilling on their Stanton Street facility to avoid potential cross contamination of shallow and deep groundwater. The general procedures are outlined on page 333 of the March 2021 Quality Assurance Project Plan.
