We are planning on taking the additional soil samples related to this area at the Broadway Mill on August 16<sup>th</sup> and 19<sup>th</sup>. The demo work will still be ongoing at this point but we were able to coordinate with the demo contractors to sample these days. I will provide the group with an additional update on time frame for when we expect to see the results once the samples are submitted the laboratory.

I do just want to confirm that the facility only needs to retest the sample location that exceeded the toxicity threshold for lead. Part of the retest at this location will include taking additional step out samples from this location approximately 10 ft out. Samples will be tested only for RCRA 8 Metals (total analysis).

Hi Jackie and Melissa,

It was nice talking to you both today!

**Summary:** 

As discussed on the phone, there is an area within an existing building at the GP Broadway Mill location where a boiler is being demoed that will be replaced with a natural gas boiler. Excavation of soil will need to happen in the future for installation of the foundation for the new boiler. Therefore, soil samples were collected (by coring through the existing cement floor to access subsurface soil) in this area for total PCBs, TCLP VOCs, and TCLP metals (This sampling was done prior to when we had the discussion regarding analyzing for totals and TCLP, not just TCLP). There were no detections for total PCBs and TCLP VOCs. There was one sample location that exceeded the toxicity threshold value of 5mg/L for TCLP of lead at one location and there were some other metals detected below the toxicity threshold values.

### **Actions to Complete:**

- Soil samples need to be collected for RCRA 8 metals (totals analysis) in the location of the detected metals and step-out samples within approximately 10'. You stated that access to this location likely won't be available for this sampling until after the current boiler is demoed.
  - Once you find out, please reply with an approximate timeframe of when you will be able to collect the additional soil samples.
- Once the additional soil samples have been collected, provide a letter report with the data and figure(s) showing sample locations along with the Notification of Discharge Form (Form 4400-225), which can be found at the following link: <a href="https://dnr.wi.gov/files/PDF/forms/4400/4400-225.pdf">https://dnr.wi.gov/files/PDF/forms/4400/4400-225.pdf</a>.

The DNR will evaluate the documentation at the time it is received to determine if a new case needs to be opened. Based on the information that is currently known, it is likely a new case will be opened.
