Hi Adam,

Things to keep in mind when considering this:

- For any new discharges that may potentially be caused as a result of the operation, the City of Manitowoc and/or local contractor would not be exempt from liability, so preventative measures should be taken to minimize the potential for this to occur.
  - Make sure the City is comfortable with the characterization of the area that will be used for the temporary operation, so if a new discharge does potentially occur, the City will be able to distinguish between historic contamination and the new discharge.
- The City and local contractor will want to ensure that protective measures are being taken to
  ensure safety of the workers who could be in contact with residual contamination, especially soil
  which has contaminant concentrations above direct contact soil standards.
- The City and local contractor will want to ensure that protective measures are being taken
  during the temporary operation to prevent existing contamination from getting commingled
  with other materials and/or prevent contamination from leaving the site.
- I would agree with restricting this to non-VPLE proposed areas only.

# Good morning Tauren,

The City is considering working with a local contractor to utilize a portion of the CN Peninsula for a temporary concrete crushing plant. The use would be tied to two local road reconstruction projects. Concrete from the existing roadway would be crushed and then the material would be reused on the roadway projects as granular fill. Before potentially moving forward, I wanted to ensure that we were not creating a larger issue. Our intent would be to restrict the use to non-VPLE parcels. A tracking pad would be utilized to restrict current CN soils from leaving the site. Likely location would be the southeast corner of the site where we have planned on stockpiling clean fill.
