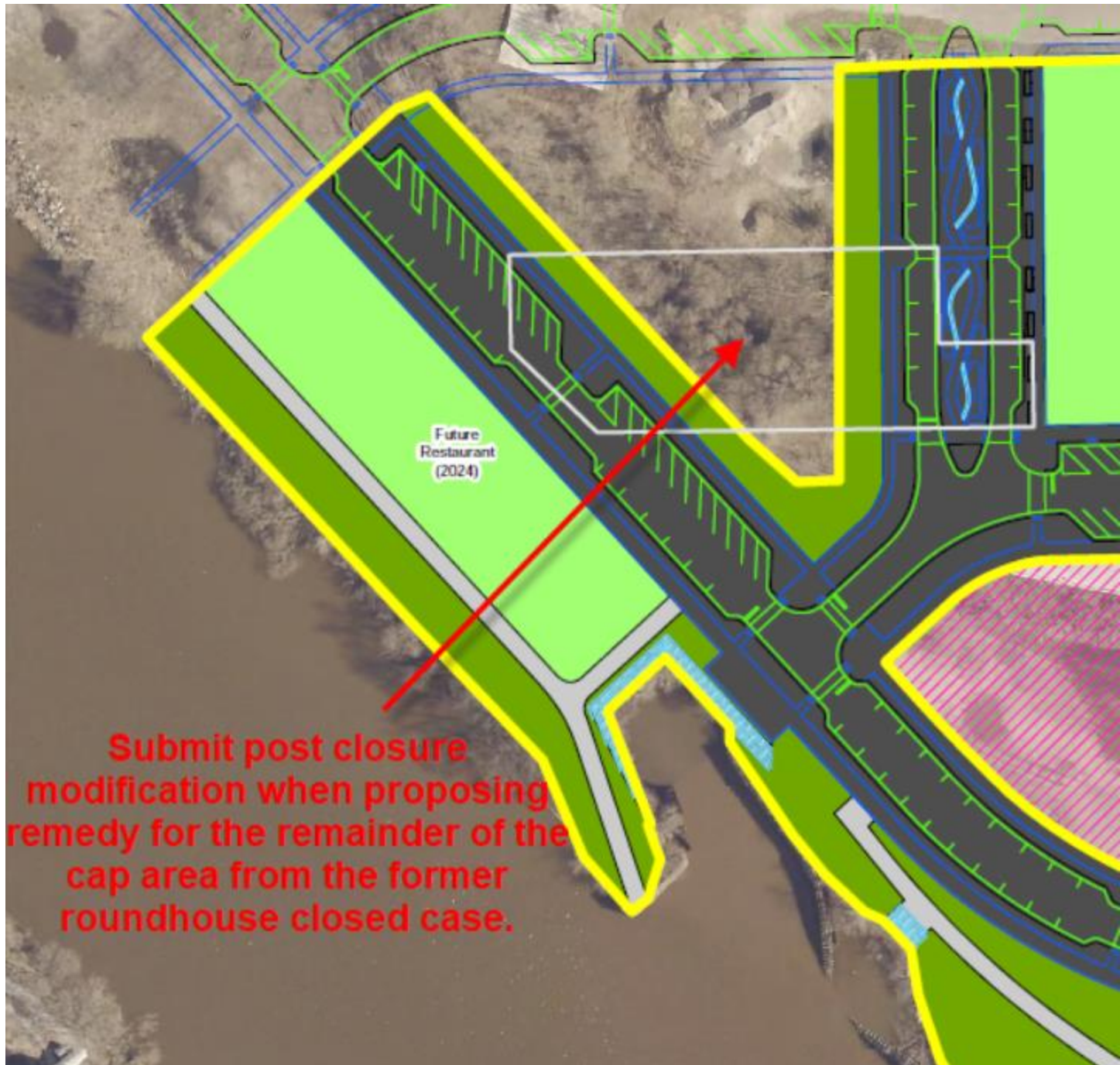

In regard to your post closure modification question, DNR has decided that at this time you should not submit a formal post closure modification request yet for the former roundhouse closed case. You are only addressing a portion of the cap at this time, so DNR thinks it is best to submit the formal post closure modification request when you propose the remedy to address the remainder of the cap area for the former roundhouse closed case (see screenshot below). That way, the closure addendum letter that would be issued at the end of the post closure modification process will be able to address the entire cap from the former roundhouse area all at one time.

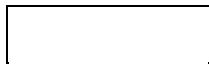
