Hi Melissa,

DNR has reviewed the *PFAS Expanded Site Investigation Summary Report* received on July 2, 2021. Based on this review, a follow-up confirmatory sampling round from the existing monitoring well network is recommended prior to the installation of any additional monitoring wells to better define degree and extent of PFAS contamination in groundwater.

It is also recommended that a brief site investigation work plan be submitted outlining proposed well locations as well as areas on the property where PFAS could have been used/discharged historically.

It is noted that several of the monitoring well screens were fully submerged below the water table when groundwater elevations were measured.
