Your request for an extension to submit the Long Term Monitoring Plan for surface water and sediment is approved. That being said, I will be out of the office December 22, 2021 through January 3, 2022. Please submit the Long Term Monitoring Plan for surface water and sediment on or before **January 4, 2021**.

As a follow up to the referenced call there were a few questions outstanding that I needed to get back to you on.

1. **Request not to do a BSAF Model:** As indicated on the call the comments related to the BSAF model are merely intended to call attention that you may need to make different considerations if you do move forward with the model.
2. **Request to do a single QAPP:** As indicated on the call, only one project QAPP is necessary and it should include all relevant information for all of the work plans.
3. **Surface Water Analytical Method:** The surface water sampling needs to be congener based, as the Aroclor method is not sufficiently sensitive, precise, or accurate. A review of the Wisconsin certified laboratory list indicates that there isn't a lab certified for Congeners other than by High Resolution Gas Chromatography-Mass Spectrometry.
