Thank you for having the call with us this afternoon regarding the fish tissue sampling activities. It was helpful. Below is a summary of discussion points and questions that were addressed on the call.

- The group discussed the application of the rule that the smallest and largest fish in a given species must be within 75% of each other for total length. We discussed the language in section 4.2 of the NRMP and asked for confirmation that this rule should only apply to composited species under the ecological risk objectives. WDNR agreed and the group came to the consensus that the 75% rule does not apply to samples comprised of individual fish (i.e., all human health risk species and Common Carp).
- WDNR confirmed that it is acceptable to collect Rock Bass in the 6-8" range as an alternate size class.
- WDNR confirmed that it is acceptable to collected Black bullhead in the 6-8" range as an alternative size class.
- WDNR confirmed that Golden Shiner could be used as an additional alternate ecological species.
- WDNR confirmed that, where juvenile Longnose Dace were present (within the 2-4" or 4-6" size class), the species could be used as an alternate ecological species and/or supplement composite samples for Blacknose Dace within the same size class (i.e., juvenile Longnose Dace and Blacknose Dace within the same size class could be mixed to comprise one composite, where necessary).
- We asked for clarification on completeness goals for a given location. WDNR confirmed that
 additional effort is probably necessary where minimum target completeness goals have not
 been achieved, as indicated in the NRMP Section 4.5. We will look at where we are at the end of
 the week.

Hi Chris, I just heard back and fish comments are below:

That 6-8" for rock bass makes good sense – we would rarely see rock bass >12". Also, the bluegill target sizes seem small to me?

I doubt the public would eat a bullhead <8"?

I think it would likely be fine to substitute golden shiner.

As for the 75% length requirement, it seems clear at the end of section 4.2 that the smallest fish in the composite sample will be no less than 75% of the length of the largest individual. I believe this also applies to individual fish sampled for the optimum completeness goal (section 4.1).

Hi Chris, I haven't heard from fisheries yet but wanted to provide you some feedback asap.

- The 8-10" size for rock bass is already an alternative size. If you can not find enough 10-16" target sizes after a more exhaustive effort, then we would need to get input from fisheries to consider including 6-8" sizes.
- Again, the 10-12" is already an alternative size. If you can not find enough 12-18" target sizes
 after a more exhaustive effort, then we would need to get input from fisheries to consider
 including 6-10" sizes.
- Yes, if enough common shiners can not be found, golden shiners can be included in addition to any common shiners that you find.
- As for the 75% question, the plan first states "The smallest fish in each <u>individual or composite</u> sample from each location will be no less than 75% of the length of the largest individual." But later in the plan it says that is for composite, and then rock bass and white sucker for human health do not have a WDNR specified minimum length. So I interpret that as the 75% does not apply to individual samples.

We started the fish sampling yesterday. Based on the initial observations, we have a few questions and clarifications. We would appreciate a response asap to help complete the fish sampling.

- Would it be possible to include an alternate size category for Rock Bass for 6-8" fish? The field crew has observed a number of individuals in this size range that are of edible (filet-ready) size.
- Would it be possible to include alternate size categories for Black Bullhead for 6-8" and 8-10" fish? Again, the crew has observed a number of individuals in these size ranges.
- Can Golden Shiner be added as an Alternate Ecological Risk species (with size ranges identical to the other Alternate Ecological Risk species)? This species has been abundant in locations where Common Shiner has not been found or in very low numbers.
- Can you please confirm that the 75% length requirement does not apply to species treated as individual samples (i.e., Rock Bass, Largemouth Bass, Smallmouth Bass, Pumpkinseed, Black Bullhead, adult White Sucker, and Common Carp) only to composited species (i.e., Creek Chub, Juvenile White Sucker, Bluegill, Blacknose Dace, and/or Common Shiner)?
