Hi Matt,

We are currently detailing out the next phase of SI work, which includes the installation of additional wells and the sampling of on-site and off-site wells. We are not proposing the sampling of potable well at this time. In terms of schedule, well installation will need FAA approval and the wells are to be installed when weather/ground conditions (after Spring thaw) are conducive to the installation. I suspect in May or June for well installation/sampling. We will keep you updated as the work progresses.
