Thank you for this update. DNR was contacted by the off-site property's attorney in December; he had conversations with myself and DNR's attorney, so I understand it may take a bit to gain access.

Have the on-site wells been sampled for PVOs since the latest spill in May of last year? I have concerns with the amount of time that may pass to gain off-site access. The on-site wells may require a round of sampling before additional off-site wells are installed and sampled if access takes too long to negotiate.
