On April 23, 2024 the Wisconsin Department of Natural Resources (DNR) received a technical assistance request from Stantec Consulting Services (Stantec) on behalf of the C. Reiss Company LLC (C. Reiss). The technical assistance request was for approval to abandon several passive soil venting pipes on the Amoco Barge Dock- Manifold & AST Area site (Manifold Site) BRRTS #02-16-117873. On April 24, 2024 a fee was received by the DNR for the technical assistance request in accordance with Wisconsin Administrative (Wis. Admin.) Code ch. NR 749.

The request is for abandonment of up to six (6) vent pipe associated with a passive soil venting remediation system located on the former Barge Dock. The reason for the request is a proposed railroad corridor going into the C. Reiss property will intersect the passive venting system.

On May 2, 2024 the DNR reviewed the request and associated data. The DNR requested additional information from Stantec be provided to aid in determining if approval of the request was appropriate. On May 3, 2024 Stantec supplied the DNR with the requested information.

On May 6, 2024 the DNR reviewed the additional information and approved the request. An initial email of the approval was sent to Stantec on May 6, 2024. This correspondence is a follow up approval notification. With the approval, under Wis. Admin. Code § NR 724.13(4) the DNR is
