Thanks for taking the time to speak with us on Friday July 8, 2022. As discussed, Ramboll, on behalf of Newell Operating Company (NOC), would like to defer submittal of a Site Investigation (SI) Work Plan for the Bright Horizon Properties LLC site (BRRTS No. 02-36-589295). Ramboll has reviewed the SI Work Plan submitted by Fehr Graham (FG) on June 22, 2022, on behalf of their client West River Lofts, LLC. The SI Work Plan describes site investigation activities conducted to date along with the additional investigation activities proposed by FG which include the ongoing assessment of CVOC and PCB impacts.

In an effort to not duplicate investigation efforts, Ramboll would like to request WDNR's approval to defer submission of a SI Work Plan until FG completes the scope of work outlined in their work plan. Following review of their results we will reach out to the WDNR to discuss any appropriate next steps for NOC.
