- Table 2.2 & Figure 2.4 represent samples that were collected after the initial UST removal in April 1991. 300 cubic yards of soil were removed.
- The Boring diagram shows the location of borings and monitoring wells that were advanced in April 2022
- Table 2.4 & Figure 2.6 represent samples that were collected after the additional excavation in May 1992 after 600 cubic yards of soil were removed.
