## SITE SERVICES

**SECTION 1.0** 

### **Site Services**

(All times are Central Standard Time and are approximate)

### **February 22, 2022**

1300 hours: EnviroServe received a request from Tracie Murphy of Spill Center, Inc. to respond to an estimated 25-gallon, diesel fuel release by Aim Transfer & Storage at Hentzen Coatings, 6937 West Mill Road, Milwaukee, Wisconsin. The release occurred when a fuel line drain valve on a semi-tractor was damaged.

1400 hours: An EnviroServe team member arrived on scene and met with the environmental manager. In addition to the release incident, stormwater drainage was discussed. Absorbent booms, absorbent pads, granulated absorbent, and drain covers were already deployed at the release site by others.

The team member inspected the storm sewer outfall to Noyes Creek located approximately 0.25 miles west of the release location Initial visual inspection did not detect a petroleum sheen in the creek. Absorbent booms were placed across the creek as a precaution. A small ribbon of sheen appeared during boom deployment. The source of the sheen was not obvious at that moment.

1745 hours: The team member vacuumed free product from water collected at the covered storm drain inlets. The product was placed in 55-gallon, open top, steel drums. Petroleum saturated booms were replaced. The environmental manager and the client were updated. The team member demobilized from the project site returning to EnviroServe's Milwaukee Operations Center.

### **February 23, 2022**

0700 hours: An EnviroServe team member arrived at the project site. Absorbent booms were inspected. Petroleum saturated booms were replaced. Visual and olfactory evidence of diesel fuel impacted water at storm inlet SD3 were noted (Fig. 1). The absorbent boom at SD3 was inspected then re-deployed.

The Noyes Creek boom was frozen in ice. A petroleum sheen was migrating beneath the boom. An addition absorbent boom was installed in a riffle downgradient from the frozen boom. The team member updated client and Henzten Coatings.

### **February 25, 2022**

1530 hours: An EnviroServe team member arrived at the project site to perform boom inspection. The creek booms were petroleum saturated and replaced. Additional booms were deployed in the creek. Petroleum saturated storm drain inlet booms were removed and replaced Booms with additional capacity were re-positioned.

1745 hours: The team member departed the project site in route to EnviroServe's

Milwaukee Operations Center.

### **February 28, 2022**

1530 hours: EnviroServe's team members removed and replaced petroleum saturated booms in the creek and on the project site. A team member updated the client and the landowner.

### March 1, 2022

1400 hours: EnviroServe's team members arrived at the project site to inspect booms in Noyes Creek and at the project site. Diesel fuel odor was noted upon arrival. The team members noticed free product present in the creek coming to the first boom station BM1 and flowing north of Acacia Street West. Additional booms were deployed downstream of BM1 through BM6. Project site absorbent booms were redeployed in SD1 through SD3 as a preventative measure. A team member updated the client and Hentzen Coatings.

Coincident to the free product observed in the stream, the team members observed a sanitary overflow at the Beyond the Norm Carwash, 7323 W Mills Road, adjacent to the stream.

1425 hours: Additional booms were deployed downstream of BM1 through BM-6 (Fig. 2). The additional boom stations spanned over 1,500 feet of the north flowing stream between Mill Road and Acacia Street totaling 120 feet of boom at six locations. A team member updated the client.

### March 2, 2022

1600 hours: Team members inspected boom stations BM1 through BM6. A petroleum sheen was still present in Noyes Creek. Petroleum saturated booms were removed and replaced. Other booms were flipped and re-deployed. A team member updated the client via electronic mail. Due to the increased amount of diesel fuel entering the stream, Enviroserve began daily boom checks. The daily boom checks continued through March 11<sup>th</sup>. Enviroserve developed a plan approved by their client to jet the storm drains and vacuum the jetted effluent for waste treatment.

### March 15, 2022

0500 hours: Team members arrived at EnviroServe's Milwaukee Operations Center to load materials and prepare equipment.

0527 hours: Team members departed the Milwaukee Operations Center in route to Milwaukee waterworks.

0800 hours: Team members arrived at Milwaukee waterworks and started filling water tanks.

0900 hours: Team members departed Milwaukee waterworks in route the project site.

0915 hours: Team members arrived at the project site. Team members prepared equipment and inspected the job site.

1000 hours: Team members discovered a damaged connection on the combo truck causing a vacuum leak. The truck was unable to perform the necessary work. Team members demobilized from the project site in route to EnviroServe's Milwaukee Operations Center to unload the water.

1200 hours: Team members returned the broken equipment to the rental facility. Team members returned to EnviroServe's Schererville Operations Center.

1600 hours: Team members arrived at the Schererville Operations Center

1630 hours: All project related activities were completed for the day.

### March 18, 2022

1400 hours: Team members performed boom checks, then flipped and redeployed all boom.

### March 23, 2022

1200 hours: Team members performed boom checks after 0.63 in rainfall. No additional sheen was observed.

### March 24, 2022

1030 hours: Team members performed boom check after 0.97 inches of rain. Diesel sheen present at BM1. The absorbent boom was saturated with petroleum. After updating the client the concerned parties decided to perform the storm sewer jetting project as previously proposed.

### March 25, 2022

1345 hours: Team members inspected the absorbent booms at the project site. Petroleum saturated booms were removed and replaced. Other booms were repositioned.

### March 30, 2022

0700 hours: Team members mobilized a vacuum truck and support vehicles to perform the storm sewer jetting project beginning at Hentzen Coating storm drains.

1100 hours: Team members completed jetting at SD1 at Hentzen Coating. The team

members encountered a strong smell of diesel while vacuuming this jetted storm drain.

1500 hours: Storm drains jetting on West Mill Road was halted due to lane closure restrictions.

### **April 1, 2022**

0700 hours: Team members mobilize to the project site to complete the storm drain jetting project on West Mill Road.

1430 hours: Team members completed the storm drain jetting project.

1730 hours: Approximately 0.39 miles of storm drains jetted and effluent vacuumed and transported to treatment facility. A team member updated the client.

### April 4, 2020

0630 hours: Team members arrived at Noyes Creek to remediate residual fuel out of riparian vegetation and sediments. Team members used a rake and their feet to disturb the sediment on the bottom of the stream. The agitation released diesel fuel impacted stream vegetation and sediment. The petroleum was collected with an absorbent boom deployed downstream from the area. This process continued downstream to each boom station. The downstream boom was removed after each reach of the creek was remediated.

### **April 6, 2022**

0810 hours: Team members arrived at the project site. After confirming the air quality was safe for human occupation, a team member entered the outfall underneath Mill Road. A team member used a rake and their feet to disturb the sediment on the bottom of the stream. The agitation released diesel fuel impacted stream sediment. The petroleum was collected with an absorbent boom deployed downstream from the area.

### **April 13, 2022**

1400 hours: A team member arrived at the project location to inspect the absorbent booms and continue the process of remediating the riparian vegetation and sediments as described above.

### **April 15, 2022**

1300 hours: Team members continued agitating the residual diesel from the creek bed and bank of the stream. A team member updated the Wisconsin Department of Natural Resources Spill Coordinator with stream conditions The coordinator believed the stream had been remediated to the extent practicable, a standard for case closure. Team

members removed the remaining booms from the creek and completed the active remediation phase of the project.






Thank you for providing the cleanup update and photo. Please continue to keep me updated and please ask EnviroServe to provide an estimated timeline for the remaining cleanup actions needed to clean up the spill to the extent practicable. Additionally, please keep in mind that, per Wis. Admin Code NR § 708.05(6), the DNR requires the submittal of written documentation of the immediate actions taken and the outcome of those actions, within 45-days after the hazardous substance discharge (spill) notification. Wis. Admin Code NR § 708.09(1) specifies the requirements of the preparation and submittal of the final spill cleanup report to the DNR. These cleanup reports are typically created by the contractor(s) performing the cleanup as they have the most hands on knowledge of the actions taken. It is useful to include photos and figures, as may be applicable, as supporting cleanup documentation. Once this report has been completed, it can be emailed to me.

Quick update on above site cleanup progress, as received from Enviroserve yesterday evening 4/6:

"we completed the jetting and vacuum of the stormwater system on Friday April 1st.

Today we started mobilizing the diesel from the creek bed and bank vegetation into the existing boom array starting at the outfall where stormwater enters the creek.

We did well to mobilize sheen but found pockets of diesel free product as seen in the attached image. Going forward we will use hard boom in the creek to recover any additional free product that we encounter.

We will be back at it tomorrow afternoon and will update you on our progress"

Quick update on above incident, please see below as received from Enviroserve. They were out on site yesterday to begin jet/vac of the drainage system. Returned today, however, snowstorm in the area has impeded progress, and they will return tomorrow to complete, if all goes as planned. Please let me know if you have any questions or concerns. Thank you

### 3/30/2022

"We arrived at 6937 W Mill Rd at 8 AM and set up on storm drain SD2 and jet/vac the line associated with that drain. Diesel odor was produced from the cleaning at this storm drain.

We moved to SD3 and removed the absorbent boom from the drain and observed sheen and jet vac the lines associated with drain.

We moved to SD1 jet/vac the lines associated with this drain, this cleaning produced consistent strong diesel odor.

We moved to the storm sewer lines on Mill Road where one of two westbound lanes were closed for our work. Our lane closure permit limited our work time from 9am to 3pm.

We set up on the manhole at 71<sup>st</sup> and Mill and jet/vac the east west lines associated with that manhole. Diesel odor was not noticed.

After this manhole the waste water on the truck needed to be taken to the disposal/treatment facility and a jetter water refill. The closed traffic lane was reopened.

Jet/vac work will resume tomorrow morning and should conclude tomorrow afternoon.

We checked boom today and replaced 5 10' sections in 4 stations.

Once the jet/vac work is concluded we will aggressively disturb the bed and overhanging vegetation in the creek to mobilize with residual diesel into our array of boom."

Please see update below, as received from Enviroserve today, and advise if this plan of action is acceptable.

"We just inspected the outfall area at the creek after <u>0.63 inches of rain in the area</u> as measured at 5535 N Teutonia Ave since midnight.

We are not observing active discharge of diesel as evident by sheen.

If we do not proceed with the jetting and vacuum project I recommend that we remediate the stream shorelines and bed of residual diesel by mobilizing the fuel into our existing array of booms and remove the boom and monitor the same outfall area during the next rainfall event greater than 0.25 inches. If no sheen is overserved we could close out this project."


