On behalf of Scot Industries, Inc. (Scot), Ramboll US Consulting, Inc. (Ramboll) is presenting the projected schedule for the Scot site located at 1532 West Galena Street in Milwaukee, Wisconsin. Ramboll received the Approval to Proceed in the Voluntary Party Liability Exemption Process letter from the WDNR on August 16, 2022, and is proposing the following schedule for work under the VPLE program.

Previous site investigation activities have been conducted in 2021 and 2022 to evaluate recognized environmental concerns associated with historic operations identified during a Phase I Environmental Site Assessment. Specifically, activities were conducted to confirm the presence of subsurface contamination and define the extent and degree of impacted soil, groundwater, and vapor and to evaluate emerging contaminant risk at the site. A Site Investigation Report (SIR) was subsequently submitted in April 2022 documenting the results from the soil, groundwater, and sub-slab vapor activities performed to date.

Based on the initial results within the SIR and conversations with the WDNR, further investigation efforts are necessary to define and delineate the extent of impacts at the site. As such, Ramboll proposes the following schedule:
