SUBJECT: Basis for Consultant Selection, Abstract of Bids, and Summary of Actions for RFP-SLR22

The purpose of this memo is to document the selection committee's basis for consultant selection, provide an abstract of bids, and summarize DNR actions for the selection of a consultant under Wis. Adm. Code NR 734 for Professional Services for Feasibility Studies and Preliminary Designs for the Contaminated Sediment Remediation in the Superior Slips (RFP-SLR22).

## **Basis for Selection:**

The AECOM proposal for Professional Services for Feasibility Studies and Preliminary Designs for the Contaminated Sediment Remediation in the Superior Slips (RFP-SLR22) was ranked the highest, among the three proposals received, unanimously by the DNR selection committee. AECOM differentiated itself specifically through the detailed description of the work to be performed, which most closely resembled a work plan. For reference, DNR had directed the proposers to have the proposal replace the work plan. AECOM was more clear, detailed, and specific to the work to be performed than other proposers by providing the specific equipment, more clear and reasonable assumptions, and thoughtful site-specific recommendations based on their review of the existing information. AECOM appears to have more experience and a clearer understanding of the scope of services to be provided and consequently, also has the lowest costs. AECOM also differentiated itself by screening the project area with EPA's environmental justice screening tool. This was above and beyond what was required by the SOW. This likely means that AECOM understands that environmental justice is currently important to EPA and has recommendations for making the project successful. Additionally, AECOM noted on several occasions that they have specific experience related to former Manufactured Gas Plants (MGPs) and that the data review for the C Street Slip will be led by an engineer with MGP experience. As the C. Street Slip is adjacent to a former MGP and MGPs typically present a unique set of challenges this adds value. In summary, AECOM is the most experienced, clearly understands the scope of services, and provides the most detail for the lowest cost.
