4. Identity, physical state, and quantity of the material discharged.

Liquid - Heavy Crude Oil

- i. Two (2) gallons following initial discovery on November 11, 2024
- ii. Revised to three (3) barrels (126 gallons) on November 13, 2024
- iii. Revised to 1,650 barrels (69,300 gallons) on December 11, 2024
- 5. Physical, chemical, hazardous, and toxicological characteristics of the substance.

The primary toxicological concerns with crude oil are petroleum volatile organic compounds.

6. Cause of the discharge.

Flange gasket on the Line 6 Unit 4 Discharge Valve at the Cambridge Station.

7. Immediate actions being taken and the name of the contractor or other person performing the action.

Removal of impacted soil from the source area. Excavation activities commenced immediately after discovery on November 11, 2024, and continued through December 18, 2024.

Primary Response Personnel: Enbridge Energy, Limited Partnership Remediation Contractors: Charps, LLC. & Badger Infrastructure Solutions Ltd. Waste Transportation Contractors: Hausz Bros., Inc. & Clean Harbors, Inc.

8. Source, speed of movement, and destination or probable destination of the discharged hazardous substance.

The released material impacted soil at and immediately adjacent to the release location and shallow groundwater below and immediately adjacent to the release location.

9. Actual or potential impacts to human health and the environment, including actual or potential impacts to drinking water supplies.

Shallow groundwater impacts below the release location have been observed. However, sampling of the facility's perimeter monitoring wells, facility potable water well, and initial site characterization activities with groundwater sampling indicates groundwater impacts are currently contained within the Enbridge property, at and immediately adjacent to the release location.

Two (2) nearby residential potable water wells have been sampled with no detectable concentrations of contaminants of concern.

Approximately 4,000 gallons of oily liquid has been disposed of at Reworld in Hodgkins, IL. 2,913 tons of impacted soil/debris has been disposed of at Waste Management's Deer Track Park Landfill in Watertown, WI.

Final documentation is pending as final disposal activities were ongoing as of December 23, 2024. This documentation will be provided in the comprehensive Immediate/Interim Actions Report.
