On May 28, 2020, the Wisconsin Department of Natural Resources (Department) received a scope of work (SOW) and cost estimate utilizing the chapter NR 747, Wisconsin Administrative Code, Usual and Customary Cost Schedule (Cost Schedule) for the site referenced above.

The Department has determined that the submitted SOW tasks identified represent PECFA-eligible tasks. The cost exceedance request that was approved on October 23, 2018 included submittal of a Soil Vapor Extraction (SVE) System Report. To date, that report has not been submitted to the DNR. While the additional costs requested represent PECFA-eligible tasks, it is not possible for the DNR to comment on/approve SVE system decommissioning, monitoring point abandonment, groundwater sampling analysis, nor the applicable continuing obligations related to case closure without the data and analysis from that report. A partial approval of costs related to closure request preparation is being approved. This site will be deferred from the public bidding process at this time. The Department will contact you if this site will be bid in the future. A copy of the Department worksheet for the Cost Schedule tasks is enclosed for your reference.

Deferment Cost Cap Approved:

\$1,403.69 (25% of \$5,614.77)

Note: A claim for PECFA reimbursement must be submitted prior to July 1, 2020. If a claim for costs incurred is not submitted within this deadline, the costs will not be eligible for PECFA reimbursement. Be reminded that ch. NR 700 semi-annual progress reporting is required until this case is closed.

Usual and customary costs for activities included in this approval will only be reimbursed at a rate equal to or less than what is allowed on the Cost Schedule and are reimbursed based upon the Cost Schedule that is in effect at the time the activity is performed. Costs for activities not included in this approval are not reimbursable without prior Department authorization.

Regulatory Correspondence (Task 7, Activity RC05), Claim Submittal (Task 27, Activity CS05) and Standardized Invoice (Task 28, Activity SI05) costs are not included in the cap approved above. These activities will be reimbursed according to the task specifications and with submittal of proper supporting documentation at claim review time.

The Department considers the consultant the primary controller of costs during these activities. This approval does not guarantee eligibility of any specific costs that have been incurred or that may be



incurred in the future. Final determination regarding the eligibility of costs will be made by the claim reviewer when the entire claim, including all invoices and reports, is submitted for payment.
