Hi Gerry,

You understand my email correctly in regard to making a determination (aka providing the County a letter) for approval of a complete site investigation.

Just one clarification I would like to make in regard to getting these properties to case closure. A remedy (cleanup) to address the contaminated soil above non-industrial and/or industrial direct contact soil standards at the two properties is needed in order to get approval for case closure. The remedy for these sites will likely be some sort of cap as part of a redevelopment. Examples of caps can be: soil with vegetation (such as landscaped areas of a redevelopment), building foundations, pavement (parking lots, driveways), etc. I think the next step that we can discuss while we are waiting for the sediment data can be what does the County ultimately want to do with these two properties, whether it would be to sell to Mr. Carey for his business or some other land use, since the redevelopment of these properties will also likely act as the remedy. You can discuss this more with Lynn and let me know if you have questions. I would be happy to get a

Green Team (redevelopment) meeting together with you (the County) and Lynn to discuss grant options and redevelopment scenarios.

Hi Lynn,

It was nice to meet you as well! As discussed with you last week, I just wanted to provide a follow up email on the White and Lesperance properties to summarize our conversation and to discuss next steps.

For the Lesperance property, the additional soil samples collected on the east end of the property had detections of contaminants above direct contact standards, so the contamination in fill will be considered to be property line to property line, because it was not able to be specifically delineated.

For the upland portion of both these sites, there is no additional investigation needed to define the degree and extent of contamination in soil and groundwater. The entire site investigation cannot be approved until all media impacted or potentially impacted from the White and Lesperance properties is investigated. The primary issue with this is sediment in the river. There is a current sediment and surface water investigation being conducted in two phases by WPS as part of their open case to the north, which includes sampling to characterize degree and extent of contamination that migrated from that property. The sampling encompasses the sediment in the river adjacent to the White and Lesperance properties and surface water sampling. The first phase of that sampling was completed in August 2017; however, I am still waiting for the sediment analytical results to be submitted. I just received the surface water sampling results yesterday. Since the sampling is being done in two phases, I am uncertain at this time if the phase one sampling will be sufficient to conclude that the entire site investigation for the White and Lesperance properties is complete. I have recently reached out to WPS to see when they plan to submit the sediment results. A couple other things I want to look into is some old sediment sampling data from the late 90's and early 2000's that I found in the WPS file and if there is more information in the White Property file around the time of the EPA removal in the 90's that could help with clarification on potential releases to the river from the White Property. After my review, if the historic information and phase one sampling is sufficient to make a case the site investigation is complete, then I should be able to prepare and issue a site investigation approval letter for the fee-based site investigation report review received on May 23, 2017.

If the phase one sampling and historic information is not sufficient, there are a couple options on how I can respond to the fee-based review request:

- 1) I can provide a response that states no additional investigation is needed on the upland portion of these sites; however, barring the pending sediment investigation, the entire site investigation cannot be approved until sufficient information is provided to the DNR for impacts to sediment (FYI – this could result in an additional fee for the site investigation if a detailed review and response is requested from the County in the future, but we can discuss this); OR
- 2) I can keep the fee-based review paused, until I can provide a conclusion on the sediment investigation. (FYI - The sediment investigation can become a lengthy process so this could be a longer timeframe for the WPS investigation).

I apologize this has been delayed since the end of May. The WPS site creates a lot of complexities with off-site migration of contaminants similar to those found at these two sites. I will follow up with you once I have had a chance to look at the historic information and I am assuming I should be receiving the phase one sediment results soon.

This is up to the County on how they would like me to proceed. I also want to follow up with Rick Carey, since he has requested a status update, but I will do that after I have received a response from the County.

Good Afternoon Tauren,

It was nice to meet you the other night. And I just spoke with the County and we are tidying up the WEDC paperwork so if you would like to discuss the closeout options for the County after Thanksgiving via a phone conference just let us know a good time/date.

Also, I've compiled the data for the reimbursement request for the two additional DNR borings on these sites (S-13 and S-15) and the information is attached. I think this summarizes what was done and how the costs were broken out. Overall, because everything was part of the site activities I used a pro-rated ratio of 0.092 to calculate the costs for DNR purposes (composed of the your 6 feet of borings divided by the total 65 feet of boring depth). Therefore I prorated the per foot costs, abandonment costs and the mobilization and decon fees, etc. The lab costs were direct at \$185.00 and I pro-rated the Ayres costs as well.

All the documentation and backup is included, please let us know if you require anything else.

Hi Lynn,

No problem, it's crazy here too! Thanks for the update on the various sites! The following is what I have summarized from my review of the latest SI report you submitted and was going to provide to the City and Rick Carey on the status of these sites:

I have looked at the additional investigation data and these two sites (2022 School St and 1910 20th St) are primarily impacted with contaminants that are found in soil historically brought in to sites to fill areas to a higher elevation adjacent to a waterway, combined with some historical releases on both sites that likely contributed to some of the contamination in soil and groundwater as well. The 1910 20th St property did have more contamination in soil historically and it was removed by excavation and proper disposal, but there is some remaining contamination left over on-site. Also, WPS, with their investigation on the property to the north of 2022 School St, will be doing a sediment and surface water investigation in the river starting in the first week in August 2017 that includes collecting samples in the river adjacent to the WPS site and adjacent to these two sites. The data in the river will provide information of what contamination migrated to the river from the WPS and/or from these two sites (if applicable).

For the most part, barring one minor issue with soil fill extent, and waiting for the WPS sediment investigation results to be submitted, the investigation for these two sites is near completion and will likely not change the appropriate cleanup method needed for these two sites. Based on the data, the primary cleanup/remedy will likely be to place pervious (i.e. soil) or impervious (asphalt, concrete, etc.) covers over the contaminated soil to prevent direct contact with it. This will need to be done before DNR can provide final closure for these two sites. Examples of cleanup options could include: property improvements, what plans you or the County have for these properties (such as redevelopment) which you, the County, and/or the County's consultant will need to discuss. I can assist as well if there are questions.

I will send this information to the City and Rick once you have had a chance to look at it.
