Bill,

The purpose of this communication is to document the objection of Navistar, Inc. to the correspondence that the State of Wisconsin Department of Health Services and Department of Natural Resources indicated late last week it would transmit to owners of residential properties in an area of Waukesha known as the Phoenix Heights subdivision, formed roughly by Perkins Avenue to the north, Whiterock Avenue to the west, East Main Street to the south and the continuation of Perkins Avenue to the East.

Navistar objects to the State's communication because it contains legal and technical inaccuracies regarding the responsibility of Navistar for the environmental conditions that have been identified in the Phoenix Heights area. Navistar, through its consultant, KPRG, and through my office, provided revisions to the proposed letter, in response to the request of the WDNR. However, these revisions were selectively incorporated into the State's final draft. When I wrote you, after you related to me that just one word had been excluded from our proposed revision that I had submitted to Mark Drews of the WDNR, to specifically object to the State transmitting the inaccurate letter, you got back to me, in your message of November 5, 2020, below, to effectively advise Navistar that it was "too late" and that the State would proceed with distributing the letter.

Navistar has been consistent in its approach to the investigation and response activities in the Phoenix Heights area. To accommodate the WDNR, Navistar conducted groundwater and vapor phase investigations south of Perkins Avenue in the Phoenix Heights area. This has now expanded to vapor intrusion investigations and installation of vapor mitigation measures in up to 100 residences. Navistar has convincingly demonstrated that its former manufacturing activities north of Perkins Avenue are not the source of the contamination in the Phoenix Heights area. This is perhaps most comprehensively documented in the detailed analysis that KPRG submitted to WDNR dated November 15, 2018 ("Groundwater Impacts South of Perkins Avenue") (available in the WDNR BRRTS database). The November 15, 2018 report establishes a clear basis for concluding that former industrial and railroad activity in the Phoenix Heights area are likely primary sources of the groundwater and vapor phase VOC contamination in the area. Navistar has expressed its disappointment and concern that KPRG's analysis has never received the technical review it deserves from WDNR.

Navistar revised the DHS and WDNR communication to residents of this area last week to correct the possible interpretation of the letter that Navistar is the party responsible for the Phoenix Heights contamination or that Navistar in any way concurs with that perspetive. Navistar maintains that the position presented by the State is technically indefensible. Navistar reiterates its request that the WDNR look seriously at the evidence presented by KPRG in its November 15, 2018 report. Navistar remains prepared to assist the WDNR in this consideration.
