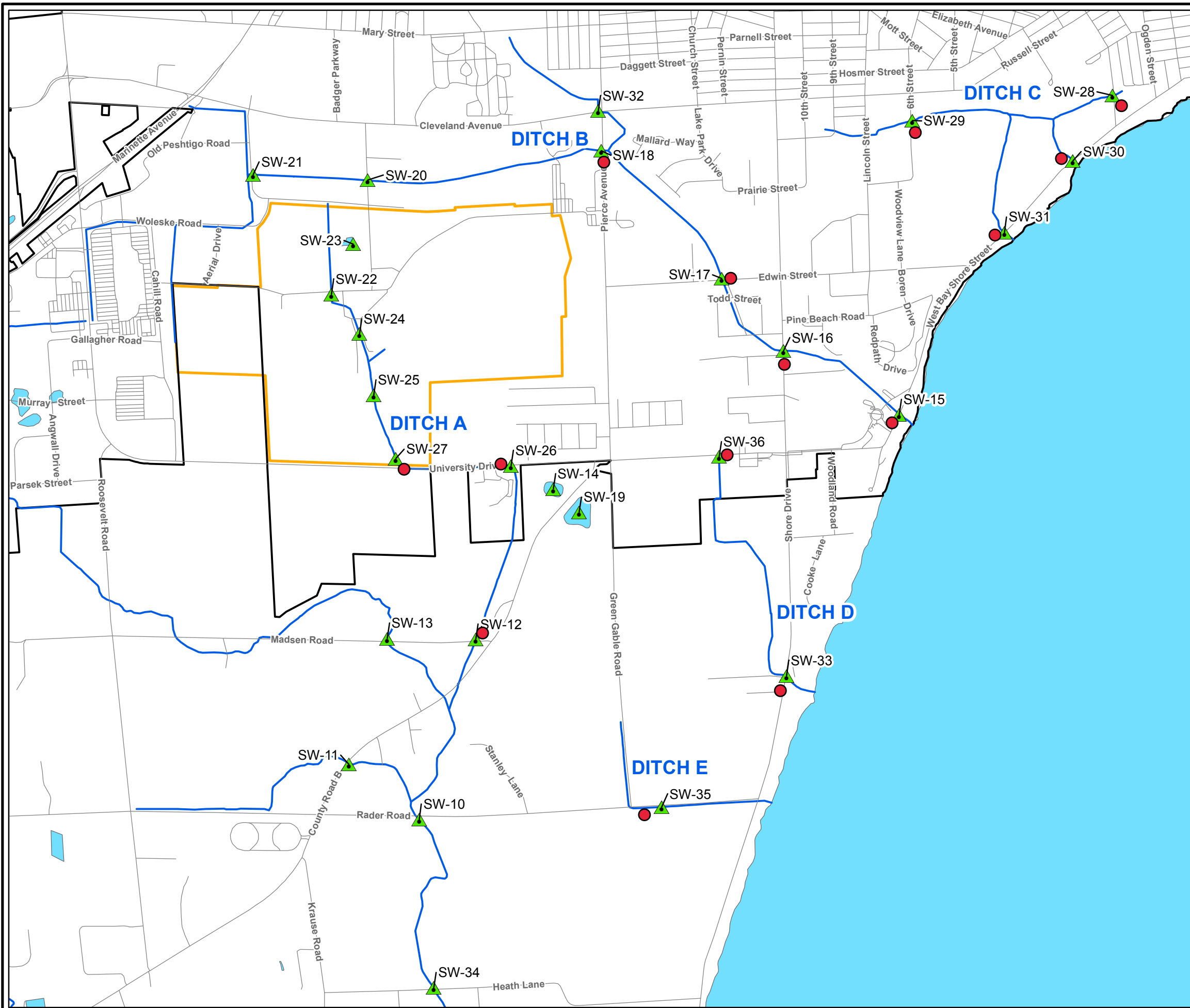

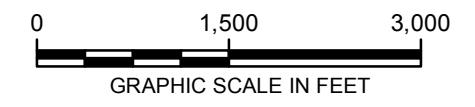

As part of the on-going investigation of per- and polyfluoroalkyl substances (PFAS) in the Town of Peshtigo and the City of Marinette, Tyco has proposed to post advisory signs at various public ditches and surface water locations in the area to inform the community of the potential presence of PFAS. You are receiving this letter because your property is adjacent to a ditch where a sign will be posted, or you have been identified as a homeowner with a pond on their property.

A copy of the advisory sign language is provided in Attachment 1 and a map showing the location of the signs is provided in Attachment 2. The sample results of the various ditches and surface water locations is provided in Attachments 3 and 4.

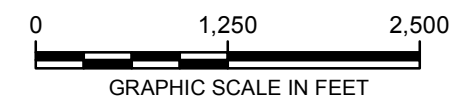

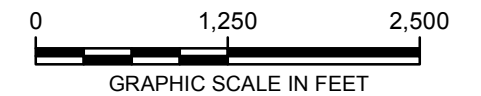

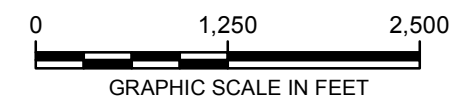
