Greg,

Continued sampling of private wells and maintenance of treatment systems is required. Sampling of monitoring wells can be temporarily suspended until further notice. At a minimum we will need current groundwater data to evaluate the next time the site is reviewed for closure. All monitoring wells should remain in place until closure is available. If/when the enforcement standard changes we will need to evaluate the currently defined extent of the plume and impacts to private wells to determine if the site investigation is complete given the new enforcement standard.

I always recommend keeping all systems and wells in place until the time closure is granted unless they are damaged, pose a risk, or are causing unnecessary or adverse complications.

As requested, I am providing a link to a guidance document that explain the Department of Natural Resources' (DNR) closure reconsideration process.

In addition, I would like to provide clarification on the current status of the site. While the DNR currently is not requiring installation of additional treatment systems on private wells with TCE detects between the proposed enforcement standard of 0.5ppb and the agreed upon 1.0 ppb, the modified 2011 Spill Response Agreement (attached) is still in effect, meaning that sampling and maintenance of the existing treatment systems is required until such time as the agreement is amended.
