Ms. Sellwood,

Attached are tables summarizing the bottled water accounts opened by Tyco on behalf of residents with drinking water wells on properties within 1,200 feet of fields that received landspread biosolids from the City of Marinette and mailing lists for our outreach efforts to date.

Overall, 196 parcels received a letter offering bottled water. The responses initiated the opening of 64 new bottled water accounts (Table 1), Identification or confirmation of 22 parcels which did not have a drinking water well, and 4 parcel owners who declined bottled water (Table 2). The remaining 94 parcels remain non-responsive to three rounds of outreach, but they will remain eligible for bottled water service while our investigation is ongoing should they elect to engage.

A summary of outreach activities to date is summarized below:

February 18, 2022, Initial mailing (Table 3)

- Notifications were sent to 193 parcels sent via FedEx overnight mail and 3 packages were sent via USPS Certified Mail due to PO Box mailing addresses 14 packages were returned
 - 7 properties were vacant
 - 5 addresses were undeliverable due to errors in the county records
 - 2 prior owners alerted us to new ownership in writing
- 3 packages were received by prior owners who contacted Tyco by phone with information on current ownership

March 1, 2022, New owner update (Table 4)

- Notifications were sent via FedEx overnight mail to 5 parcels where previous owner alerted us the property had changed ownership; Arcadis provided a copy of the original letter addressed to the updated owner

March 8-9, 2022, First follow-up mailing (Table 5)

- A second notification was sent to 147 parcels via USPS Certified First Class Mail with Return Receipt
- 124 confirmed deliveries
- 23 packages were returned
 - 4 letters were refused
 - 1 residence was vacant
 - 9 addresses had no mailbox
 - 9 letters were unable to be forwarded

March 24, Second follow-up mailing (Table 6)

- A third notification was sent to 108 parcels via USPS First Class Certificate of Mailing
- 14 returned packages
 - 9 addresses had no mailbox
 - 5 letters were unable to be forwarded

A sample of each letter is also attached to this email.

In summary, more than 50% of the parcels have been responsive and approximately one third have signed up for bottled water service. Tyco will continue to provide updates to WDNR on the status of bottled water accounts as the program progresses.




