Review of the Site Investigation Report is complete, the Department believes the investigation is complete for all COCs except PFAS. Given the recent court decision in Waukesha county we may/may not have the authority to require you to continue investigating PFAS at the site. The Department is anticipating that it will have a clearer vision of its authority in June but I may not be able to give direction until July. Given this, I recommend not abandoning your monitoring wells until the Department can give you a clearer path forward.
