I want to address one item, the explosive potential of Hexane.

Hexane has a Lower Explosive Limit of 1,100 ppm which translates to 3,876,994 ug/m³.

The concentration of Hexane in SS-39 is 134,000 ug/m³.

The concentration of Hexane is 3% of the LEL. Less than 10% of the LEL is considered safe. Therefore, there is no explosion risk from Hexane at the site and explosion proof blowers are not necessary.
