On behalf of Tyco Fire Products LP (Tyco), Arcadis submits this status report to summarize activities completed, data collected, corrective actions, and WDNR/Tyco correspondence for Q1 2023, as well as planned activities for the upcoming quarter (Q2 2023). As noted in previous quarterly status reports to WDNR, Tyco will continue to provide updates on a quarterly basis to reflect current and planned activities.

PROJECT STATUS

Below is a summary of the project status for the Tyco Fire Technology Center (FTC) and Stanton Street facilities and long-term drinking water supply for the period from January 1, 2023 to March 31, 2023 (Q1 2023) and planned activities from April 1, 2023 to June 30, 2023 (Q2 2023).

- Continue quarterly private well sampling and POET OMM per the Revised Long-Term Potable Well Sampling Plan, v.7
