Hi Matt,
Drilling began August 7, 2023. The dense sand encountered in most of the boreholes created some issues with the Sonic drilling method which resulted in a slower advancement rate. Additionally, we were unable to complete the monitoring well at the AMW-08 location due to the dense sand and we are currently reviewing our drilling options. Well development will be completed this week and groundwater sampling is planned for the second week in September. We have no laboratory analytical results at this time.

Please be advised that our report will be delayed until the results of the groundwater samples have been received and validated.
