Bruce/Tom,

As we move forward with the Thomas Street design there are some monitoring wells that are located within our current boulevard area on the north side of the street that will need to be abandoned and relocated. I have our engineering firm working on getting mapping of their locations but I thought it may be beneficial to begin conversations about getting these moved and to where you and/or the DNR would require these to be reestablished. I believe we should have a good portion of our real estate acquisitions completed by late summer at which time, if city owns the property, these could be relocated. I think it would be better to move these this year as we anticipate construction beginning in early spring of 2019. Please let me know your thoughts and the process to begin this planning. Thanks.
