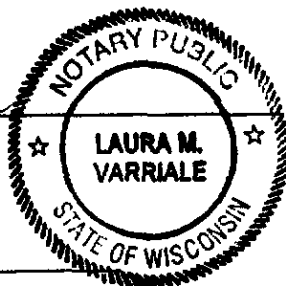

**LEGAL DESCRIPTION OF PROPERTY OWNED BY RONALD L. AND
PATRICIA A. KAUTZ - "THE INWOOD" LOCATED AT N9503 CTY RD K,

Outlot Twenty-five of the Assessor's Plat of Out lots of Hatfield, located in the Southeast Quarter of the Northwest Quarter of Section Three, township Twenty-two North, Range Three West; and the following tract of land located in said Southeast Quarter of the Northwest Quarter of said Section Three, Township Twenty-two North, Range Three West, described as follows:
