Upon Motion of Trempealeau County and the filing of the affidavit of the County's Treasurer pursuant to Sec. 75.521 (8), the court having heard statements of counsel and any other parties appearing at a hearing conducted December 7, 2011 at 2:00 p.m. and reviewed proof of publication, the report of the Guardian ad Litem, and other documents on file, the Court, renders final judgment as follows:

- 1) Trempealeau County is vested with an estate in fee simple to the following described real estate, Subject to all unpaid taxes and charges subsequent to the year 2007 and further subject to any recorded restrictions as provided in Section 75.14 (4), Wis. Stat.


A parcel of land located in the SW ¼ of the SW ¼ of Section 28-19-8 West, City of Galesville, Trempealeau County, Wisconsin, described as follows:

Commencing at the Southwest corner of said Section 28; thence East along the South line of said Section 28, 1139.50 feet to a centerline of STH 53, said point being a point on a curve concave to the Northwest having a radius of 477.50 feet and a central angle of 11° 09'; thence Northeasterly along the arc of said curve and said centerline 92.92 feet, the chord of said curve bears North 34° 07' 30" East and measures 92.78 feet; thence North 61° 27' West 33.00 feet to the Westerly right-of-way of STH 53, said point being a point of a curve concave to the Northwest having a radius of 444.50 feet and a central angle of 9° 40'; thence Southwesterly along the arc of said curve and said Westerly right-of-way 74.99 feet to the point of beginning of this description; the chord of said curve bears South 33° 23' West and measures 74.90 feet; thence South 88° 58' West 66.80 feet; thence N 0° 24' West 90.40 feet; thence South 86° 05' East 14.25 feet; thence North 36° 12' East 58.50 feet; thence North 77° 35' East 33.40 feet; thence North 37° 38' East 113.60 feet; thence South 50° 39' East 45.00 feet to the Westerly right-of-way of STH 53; thence South 28° 33' 00" West along the Northwesterly right-of-way line 161.13 feet to a point, said point being a point of a curve concave to the Northwest having a radius of 444.5 feet and a central angle of 9° 40'; thence Southwesterly along the arc of said curve and said Westerly right-of-way 74.99 feet to the point of beginning.

- 2) All persons, both artificial and natural, including the State of Wisconsin, infants, incompetents, absentees, and nonresidents who may have had a right, title, interest, claim, lien or equity of redemption in such lands are forever barred and foreclosed of such right, title, interest, claim, lien or equity of redemption.


