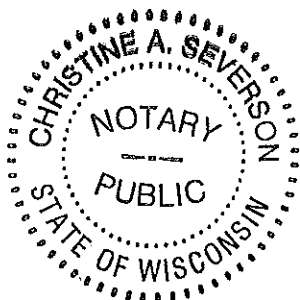

Dawes and Ina Dawes, husband and wife on April 22, 1950 and described as follows: Commencing at a point on the South line of said forty that is 117 feet West of said Southeast corner and running thence West 63 feet or to the West line of the above-described tract, thence North along the West line of the above-described tract 63 feet to a point, thence Southeast at an angle of 45 degrees to point of commencement, being more fully described in Deed recorded on April 22, 1950 in Volume 117 of Deeds, Page 299, Adams County Records. All property located in the Town of Monroe, Adams County, Wisconsin.
