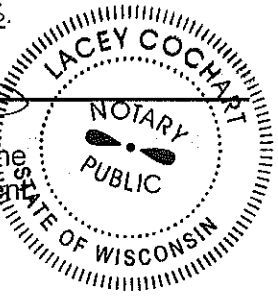

That part of the East 20 acres of the South West One-quarter (1/4) of Section numbered Six (6), in Township numbered Six (6) North, Range numbered Twenty-one (21) East, in the City of West Allis, County of Milwaukee and State of Wisconsin, bounded and described as follows: Commencing at a point in the East line of said 1/4 Section, 1760 feet South of the North East corner thereof; running thence West on a line 1760 feet South of and parallel with the North line of said 1/4 Section to a point in the West line of said East 20 acres; thence South along the West line of said East 20 acres, 100 feet to a point; thence East on a line 1860 feet South of and parallel with the North line of said 1/4 Section to a point in the East line of said 1/4 Section; thence North along the East line of said 1/4 Section, 100 feet to the place of commencement, resrrving [sic] the East 30 feet for Street purposes.

The West 25 feet shall be used as a temporary access road until the street on the East of said East 20 acres is accessible from West Lincoln Ave, to a point approximately 1350 feet North of West Lincoln Ave.
