1. I am a Remediation and Redevelopment Program supervisor, employed by the Wisconsin Department of Natural Resources (hereinafter "the Department") at its regional office or service center.
2. I have personal knowledge of the facts herein set forth and believe the same to be true.
3. The contaminated soil, vapor, sediment, and/or groundwater for which the department recorded a Notice of Contamination, dated April 27, 2001, have been addressed to the satisfaction of the department and the residual contamination that exceeds existing state standards on the above-described property is inaccessible or otherwise impracticable to remediate.
