As provided by §292.64(3), Stats., the Department of Natural Resources (department) has incurred the cost of **\$26,407.00** for the removal of the Underground Storage Tank System at the following property owned by **Jamal Shiekh and located in Racine County.**

**Property Description:**

That part of Block 1, Perkins Second Addition to Burlington, according to the recorded plat thereof, bounded as follows: Beginning at a point 7 rods North 25° West of the most Southerly corner of Block 1, Perkins Second Addition to Burlington; run thence North 65° East 2 chains 97 links; thence North 58° West 1 chain 36 links South 42° West 8 feet; thence North 58° West 1 chain 50 links to Geneva Street; thence South 43° West along the Southerly line of said Street to the corner of Dyer and Geneva Street; thence South 25° East to the place of beginning. EXCEPTING that part conveyed to the City of Burlington by deed recorded June 17, 1957 in Volume 610 of Deeds, page 147, Document No. 663060. Said land being in the City of Burlington, County of Racine and State of Wisconsin.

The Tank System removal cost incurred by the department is Twenty Six Thousand Four Hundred and Seven Dollars (**\$26,407.00**), as described in Section 292.64(3), the property remains subject to this lien until the tank removal costs are paid in full to the department. No Interest is recoverable on this lien.

The department makes and files this claim for the interest held by the Owner(s) in this property under §292.64(3), Stats. The department certifies that to the best of its knowledge and belief, all information contained in this Modified Notice of Lien is correct, and this lien represents a legal encumbrance upon the property. Based on the above information, the department claims a lien on all the interest, which the Owner(s) have in the above-described property.
