As provided by §292.63(4)(ee), Stats., the Department of Natural Resources (department) has granted a waiver of **Twenty Five Hundred Dollars (\$2500.00)** for the deductible due from the owner of property eligible for reimbursement of petroleum cleanup costs under the Petroleum Environmental Cleanup Fund Act (PECFA) to **Dunn County** owner(s) of the following property:

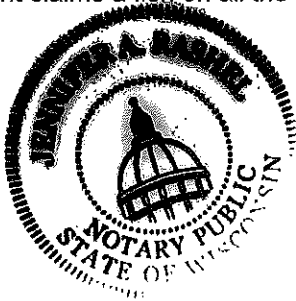
