## NOTICE OF LIEN

As provided by §292.64(3), Stats, the Department of Natural Resources (Department) has incurred costs in the amount of \$11,900.00 for the removal of an abandoned underground petroleum storage tank system on behalf of Paul W. and Mary A. O'Brien, owner of record of the following property:
