Applicant Qualifications:

1. All successful applicants (resident or non-resident) must possess a valid Wisconsin gun deer hunting license prior to participating in the hunt. In order to purchase either license, persons born on or after January 1, 1973, must present a certificate of accomplishment or equivalent which indicates completion of a hunter education course which is recognized by the DNR, a hunting approval that was issued during the prior 365 days or for a hunt which concluded within the prior 365 days, or proof of successful completion of basic training in the U.S. Armed Forces, Reserves or National Guard. All hunters (resident or non-resident) must possess a valid WI gun deer hunting license prior to the hunt.
2. If the number of applications exceed desired permit levels, a random draw will be used for selection.

Hunt Participation Rules:

1. **Successful applicants are required to review all Sandhill Hunt Regulations prior to the hunt.** If selected for this hunt, information materials and a liability waiver will be sent electronically or via standard postal service.
2. All successful applicants will be issued one Either-Sex BONUS tag and one Antlerless Only BONUS tag.
3. Only successful applicants will be admitted into Sandhill for the hunt. Harvest permits will be issued upon entering Sandhill and valid for the compartment listed on the permit.
4. The 2-day hunt will be held Saturday November 02 – Sunday November 03, 2024.
5. Successful hunters are required to present all deer harvested pursuant to a Sandhill Firearm Deer Permit for CWD testing upon exiting the property. Capes may be damaged due to testing procedures.

Instructions:

1. Each applicant must provide name, address, telephone number, birth date, DNR Customer ID#, and email address. Also designate which method is preferred for informational material delivery (either email or postal service).

(INCOMPLETE APPLICATIONS WILL BE AUTOMATICALLY REJECTED).

2. Only one INDIVIDUAL application is permitted for each hunter. Only one GROUP application is permitted for each group of **“up to four hunters”**.
3. **The application deadline is September 20th, 2024.**
4. **All successful applicants will be notified by October 4th. Non-selected applicants will not be notified.**
