

## **REFORESTATION INFORMATION**

For a successful tree planting experience, please seek professional advice from your local DNR forester or private consultant forester to develop a tree planting plan which will address species selection, site preparation needs, cost share programs available, tree planter rental options, information on forest tax law programs and other forest management topics. ## **APPLICATION INSTRUCTIONS**

1. Legibly print your name, address, phone number, delivery method and location where the trees will be planted (county and legal description). The section, township and range can be found on your tax receipt or by calling the County Clerk of Records. If you do not receive confirmation from the nursery in 10 days, please call to check on the status.
2. A **minimum order** is a packet of 300 trees or shrubs (you select the species for the your packet– increments of 100), 500 shrubs or 1000 trees. Orders of 100-400 seedlings must be purchased in lots of 100 seedlings of the same species. To receive a price reduction for larger orders of 500 - 2900, you must purchase a minimum of 500 seedlings of the same species; for orders of 3,000 or more, you must purchase a minimum of 3,000 seedlings of the same species. Please contact the nursery in spring to schedule a pick up date for April or May.
3. An **uncounted/bulk order** consists of at least 3,000 trees of **one species and age** (EXCEPTION: uncounted orders are not accepted for certain species). The number of trees shipped is based on bed-run inventories and may contain 10% more or less than the number of seedlings ordered. Landowners should grade seedlings before planting to remove damaged and inferior seedlings. Uncounted stock have discounted prices because they are not graded at the nursery.
4. Optional **DNR Reforestation Program shipping** is available at \$7.00 (300 to 1000 seedlings) or \$0.70 per 100 for 1000+ seedlings. **All stock picked up at Griffith and Hayward will be assessed a shipping fee.** If you pay for this service and later chose not to use it, then the DNR Reforestation Program must be notified before **March 15th** for a refund to be issued.
5. A **5.5% sales tax** must be added to the total nursery order. Seedlings used for silviculture purposes may be tax exempt. If you believe your order is tax exempt, please complete Department of Revenue Form 211 available at <http://www.revenue.wi.gov/forms/sales/s-211.pdf>. Submit this form with your tree order application.
6. **Payment for orders submitted on or before January 31st : Do not submit money with your application.** A billing invoice will be mailed/ emailed to you. Payment is due within 30 days of the invoice or your order may be canceled. Orders larger than \$1000.00 will be billed for the entire amount; however, these customers have the option of making full payment or a 25% down payment (maximum down payment of \$500.00), with the balance due by March 15th.
7. **Payment for orders submitted on or after February 1st: Full payment must accompany your application.** Make your check or money order payable to the Department of Natural Resources. Cash is not accepted. Receipt available upon request. A confirmation will be mailed to you. Checks returned for non-sufficient funds will be assessed a processing fee. Refunds of less than \$25 will not be made unless requested by phone or in writing by the purchaser.
8. **Trees will not be shipped unless full payment has been received .**
