**Notice:** Under §§ 29.523 and 29.533, Wis. Stats., and §§ NR 21.11(1) (i), and NR 22.11(10), Wis. Adm. Code, you are required to file a monthly report with the Department of Natural Resources (DNR), whether or not fishing operations were carried on during the month. Failure to report may result in a forfeiture of \$100.00 maximum. Personal information collected will be used for administrative purposes and may be provided to requesters to the extent required by Wisconsin's Public Records Law [§§. 19.31-19.39, Wis. Stats.].

**Due Date:** All licensed fishers must submit reports by the **10th** of each month to report activities for the previous month.

### Instructions

**No Fishing Report Requirements:** If no fishing operations were carried on during the month, you may fulfill your reporting requirement by completing the section below.

- 1. Gear Types:** Provide complete license information for all licensed gear. You may report for all gear types not used on this single report.
- 2. Licensed Fisher:** Only one licensed fisher may report on a form.
- 3. Signature:** Report must be signed by the licensed fisher.
4. When you are done fishing for license year with a gear type you are licensed for, you may check the box for that gear and state you are done fishing for the season. If you decided to use your gear again before the season ends you must send in a harvest form for that month.
