ABOUT THE COMPLIANCE AUDIT DISCLOSURE

Enviro-Check is a voluntary program for regulated facilities striving to maintain compliance with all state and federal environmental regulations. As part of the program, facilities voluntarily disclose the findings of an environmental compliance audit and commit to correct any violations found according to program requirements.

This template is for those submitting the required Final Audit Report to DNR. If you choose to use a different format, please include all the information requested in this form. Submit a separate Enviro-Check report for each unique property location even if the violations found at the different locations were discovered during the same environmental compliance audit. **Please submit the final report to:** DNREnviroCheck@wi.gov. Information collected on this form may be made available to requesters under Wisconsin's Open Records law.

ELIGIBILITY CRITERIA

To be considered for the Enviro-Check program limited liability protections, the participant must meet all program eligibility criteria in s. 299.85, Wis. Stats, including submitting an audit report within 45 days of completion with the following:

- *A summary of audit findings and types of violations, if any are found;*
- *Corrective action plan; and*
- *Commitment to correct the disclosed violations with 60 days of submitting the audit report or according to a compliance schedule approved by the DNR.*

Once submitted, DNR staff will confirm your facility's eligibility to participate in the program unless you have already requested and received information on your eligibility status.

Stats.), and provide a statement that justifies the proposed compliance schedule. The compliance schedule must be approved within the 60-day deferred civil enforcement timeframe.
