Commercial Boat Dealer Registration Application

Notice: This form may be used for commercial dealer application filed pursuant to Chapter 30.50, Wis. Stats. The Department of Natural Resources (DNR) will not consider your application unless you provide all necessary information. Personally identifiable information on this form will be used to administer the registration program, for enforcement purposes, and may be used for secondary purposes.

A Wisconsin dealer registration may be used for demonstrating and/or testing a boat to a specific customer in an effort to sell or show the operation of the boat with a paid employee of the manufacturer or dealer either operating or accompanying the operator.

“Dealer” is a person who is engaged in the business of selling or distributing to customers for profit or commission and who has made a substantial financial investment in the business.

There must be a different registration number for each boat that is in the water at any given time. Registration numbers are assigned by DNR but are not provided. Dealer must create two plaques for each number assigned (one plaque for each side of the boat).

Commercial registration fees reflect a three year registration cycle that expires on March 31.

Dealer cannot operate until the decals are received and displayed as required
